## **Proxy Instructions to Unit Leaders and Members**

- -If you decide not to attend this is the tool you may use to exercise your voice at the AGM.
- -Determine if you plan to use the proxy or if you plan to attend in person. If you opt to use the proxy you may chose 1 of the following 3 methods in delivering your Proxy to the AGM.
- -Step 1 Decide who will be your proxy.

You may elect to send the proxy with a person going to the AGM or, You may elect to have the Corporate Secretary act as your proxy.

- -Step 2. Decide what your proxy will be on the measures to be voted upon.
  - -There are ballots to be cast for the appointment of the auditor, possibly in your district a vote for a new director as well as motions regarding the bylaws of the organization.
  - -In the case of each question you may decide yes or no or abstain, or you may allow your elected proxy to decide on your behalf.

Please note. Make certain you sign and date (all) pages of the proxy.

- Step 3 Delivery of the proxy
  - -You may <u>mail</u> the proxy with the proxy holder who will surrender it to the Corporate Secretary by **September 27, 2023, 1200hrs EST.**
  - -You may <u>fax</u> or <u>email</u> it to the Corporate Secretary via <u>office@ccga-ca.com</u>. If you opt to fax or email it please do so **before 1200hrs EST**, **September 27**, **2023** to ensure it arrives at the AGM.
