CCGA protocols and moving forward in light of the COVID-19 virus.

As a federally regulated corporation, the following restrictions are in place for all CCGA C&A staff and volunteers. The federal Government still requires the following mandates;

- CCGA C&A COVID Vaccine policy in effect,
- Masks are mandatory,
- Social distancing maintained,
- Sanitizing of equipment and work surfaces,
- Praxes forms and Contact tracing sign in forms are still required

The CCGA C&A is still requiring that vessel crew sizes do not exceed the 5 crew limit.

In addition to the above, all volunteers and staff are to follow the remaining protocols in each Provincial/Territorial area.

All gathering restrictions lifted, however; per federal requirements above, social distancing needs to be maintained whenever possible.

All members willing to engage in authorized activities during this time must read and sign back the MOU on insurance coverage surrounding COVID-19 as provided. Any member that has not signed the MOU, will not be able to be utilized on any CCGA authorized activity until the COVID-19 concerns are resolved.

Units will have the ability to prepare their vessels for the SAR Season. Lift in and vessel preparedness/readiness will be allowed.

- Temperatures via Infrared Thermometer should be done indoors/cabin or out of the elements (wind/cold) for proper reading.
- SMS request to be completed for approval
- SMS activity reports to be completed within 48hours (mandatory) Listing all members in attendance on the vessel or shore side.

Risk Assessment – GAR

The GAR planning and environmental score should be increased or decreased based on COVID - 19 screening information provided by JRCC/MCTS and reassessed once on-scene with the vessel that requires assistance. The use of the GAR Model Calculation risks chart should be used to complete this task, all GAR scores are to be sent to JRCC Trenton.
